Minutes of the Screening Committee for compassionate appointment held on 07.09.2023 and 26.10.2023

1. The first meeting of the Screening Committee for Compassionate appointment was held on 07th September, 2023 to have preliminary inspection for the applications received from various Commissionerates under Pune CCA for Group-C posts. The following members were present:-

- 2. The Committee members have acquainted themselves with DoPT O.M. No. 140 I 4/6/94·-Estt(D) dated 09.10.1998 and as amended time to time and the provisions contained in Board's letter F.no.A.12012/52/2018/Ad.III.B dated 15/05/2019 wherein a standard operating procedure based on a 100 point scale has been prescribed to ensure transparency and maintain uniformity in selection process for Compassionate Appointment.
- 3. The Committee decided to scrutinize all the applications received for Compassionate Appointment keeping in view the following factors:
 - (i) Strictly on the basis of the point based merit system as per Board's letter. dated 15.05.2019 issued under F. No. A12012/52/2018.Ad.III.B..
 - (ii) Applicant for compassionate appointment is eligible and suitable for the post in all respect under the provisions of relevant Recruitment Rules.
 - (iii) Duration since filing of applications for appointment on Compassionate grounds.
 - 4. A total of 28 applicants were considered for preliminary scrutiny in the current committee. The details of vacancies for the year 2023:

- 5. During the preliminary scrutiny of the individual files, the Committee members sought certain clarifications pertaining to the points scored by the applicants and their supporting documents, the basis through it was decided to convene the second Screening Committee meeting on 25.09.2023 but the same could not be held due to other urgent official commitments.
- 6. The second Screening Committee meeting was held on 26.10.2023. The Committee examined the eligible 28 applications for compassionate appointment, along with its enclosed documents including duly filled in Part A, Part B and Part C of the application, copy of death certificate, copy of legal heir certificate, copy of educational certificate of the applicants, NOC from other family members, report on details of terminal benefits/pension per month, details of movable/immovable/other assets, employment status of the applicant/ any other dependents of the government servant, the verification report of the concerned Commissionerate, as forwarded by various Commissionerates in the Pune CCA.
- 7. The scrutiny of applications as per **Annexure I** with regard to educational qualification of Graduation and above, along with all the enclosed documents, was carried out to select the most eligible candidates by applying the merit points prescribed by the Board vide letter F.No. A.12012/52/2018-Ad.III B dated 15.05.2019 for **04** available posts in the cadre of Tax Assistant and the eligible candidates for selection. Based on the applicant's request (Shri Rushikesh R. Chavan s/o late Shri Raju M. Chavan, Driver Gr I) for withdrawal of application for Compassionate Appointment the Committee recommended the same to be accepted. Incase of Shri Buddhabhushan B. Londhe s/o Shri B.R. Londhe, Sepoy, required documents were not received hence his case has been recommended for carrying forward to the next Screening Committee Meeting.
- 8. Based on the criteria of relative merit points as per Board's letter. dated 15.05.2019 and eligibility in terms of age and qualification as per relevant RR, the Screening Committee scrutinized the applications and their findings are as given in :-
