AUCTION NOTICE

Subject : Disposal of condemned Govt. vehicles - Regarding

The office of the Principal Commissioner, Central Goods & Services Tax Commissionerate, Pune-I is proposing to dispose of four Government vehicles on "as is where is basis". Details of the said vehicles are as under:

2. Accordingly, separate sealed quotations are invited for the disposal of each of the said vehicle/vehicles on the terms and conditions mention below. Persons/firms, interesting in purchasing the above mentioned vehicle/vehicles, may submit their highest quotations in the enclosed Proforma in a sealed cover addressed to the undersigned latest by 3:00 P.M. on or before 10.02.2020 in the Office of the Principal Commissioner, Central Goods & Services Tax, Pune-I Commissionerate, 2nd Floor, GST Bhawan, 41/A, Opposite Wadia College, Sassoon Road, Pune 411 001. The quotations will be opened at 04.00 P.M. on the same day i.e. 10.02.2020 in front of the Additional Commissioner(A.E.), in the office of the Principal Commissioner, Central Goods & Services Tax, Pune-I Commissionerate, 2nd Floor, GST Bhawan, 41/A, Opposite Wadia College, Sassoon Road, Pune 411 001. The bidders or their representatives, not more than one for each quotation, may be present, if they so desired, at the time of opening of Quotations. The cover should be prominently superscripted with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE".

3. The vehicles will be available for inspection between 11 A.M to 1 P.M. from 05.02.2020 to 07.02.2020 in presence of the Inspector and/or Superintendent of this Commissionerate at the place of parking as mentioned in the foregoing Table.

4. The Auction of the said vehicles will be governed by the following conditions:

- (i) The vehicles will be auctioned separately for each vehicle, not in a lot;
- (ii) The vehicles will be sold on "As is where is basis". The auction process will be conducted in presence of the Auction Committee.
- (iii) The bidders are required to pay Earnest Money of Rs. 5,000/- (Rupees Five thousand only) for each vehicle separately.
- (iv) Earnest Money is payable by means of Demand Draft drawn in favour of the Pay & Accounts Officer GST, Pune (It may be noted that payment by cheque or in cash shall not be accepted).
- (v) Quotation/s received without demand draft towards Earnest Money will not be considered and shall be rejected.
- (vi) The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of the Pay & Accounts Officer GST, Pune within three working days of the acceptance of bid.
- (vii) The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if the bidder fails to honour the

- bid. In case of failure to deposit final bidding amount, the respective vehicle may be once again taken-up for re-auction.
- (viii) The delivery of the auctioned vehicles will be arranged only after the successful bidder submits documentary evidence in support of residential status (PAN Card, Aadhar Card etc. in case of individual and Registration Certificate etc. in case of firms) and on making payment of the final bidding amount & on fulfilling of other specified conditions in this regard.
- (ix) It may be noted that the Regional Transport Office has inspected all the four vehicles and have conveyed this office that the vehicles are beyond repairs. As such, the vehicles are non-road worthy and accordingly, the successful bidder should cut part of the chassis of the vehicle/vehicles that bears imprint of Chassis Number of the vehicle and also disassemble front & rear Number Plate exhibiting Registration Number of the vehicles and submit/deposit these to this office before taking possession of the vehicle/vehicles. The said Inspection Reports of the Vehicles issued by the Regional Transport Office are available with the Superintendent (A.E.) of this Commissionerate for inspection during working hours on any working days.
- (x) The auctioned vehicles will be removed by the successful bidder within two working days of depositing the bid amount, at their own expenses.
- (xi) The vehicles will be disposed off on "as is where is basis" and no guarantee for its quality will be given by this Department.
- (xii) This Department will not owe any responsibility after delivery of the vehicle/vehicles to the successful bidder and for any other liability for using of these vehicles thereafter for any other purpose after sale. This Office will not be responsible for any lapse on his part in this regard.
- (xiii) The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.
- (xiv) The Department reserves the right to accept or reject any or all of the quotations/bids without assigning any reason thereof.
- (xv) Proforma for offering rate for disposal of condemned vehicles is available at "Annexure-A" to this Notice.
- (xvi) The reserve price is as mentioned in the table below against each vehicle.
